POSITION SUMMARY

The Food Trust is seeking an enthusiastic, creative, organized Community Nutrition Ambassador that will conduct outreach and networking with individuals and partners doing food-related work in the Kensington/Fairhill/Harrowgate communities to discuss ways that by working together TFT/PEACH can better reach and impact the people we are trying to serve.

The Community Nutrition Ambassador will live and/or work in one of the identified neighborhoods with the goal of increasing access to healthy, affordable food and nutrition education. The Community Nutrition Ambassador is responsible for helping to establish and maintain community partnerships and finding ways to connect our work with other departments at TFT. The Community Nutrition Ambassador will work in collaboration with other nutrition educators/TFT staff to reach groups and individuals within the identified communities.

ESSENTIAL FUNCTIONS

- Work collaboratively with staff and community partners to improve the health of the community through partnered efforts.
- Participate in community mapping and evaluation projects in order to better understand and serve assigned communities.
- Attend community and civic group meetings to connect TFT programs with community needs.
- Identify key community groups and community leaders in order to build productive relationships and promote collaboration.
- Identify community resources that promote food access, physical activity/ healthy eating in order to share with other partners and participants.
- Participate in cross-programming efforts with other departments at The Food Trust.
- Establish and foster relationships with residents, community members/partners and site staff within assigned communities. Complete weekly/monthly administrative tasks within communicated timeline. Support the administration of evaluation within communities as assigned.



KNOWLEDGE, SKILLS AND ABILITIES

- Understanding of The Food Trust's mission, goals, and objectives and ability to work independently with a high level of energy and contribute as part of a larger team.
- Possess cultural competencies for diverse groups
- Ability to organize tasks and follow-up in an efficient manner with strong attention to detail in a fast-paced environment.
- Knowledge of the concepts with cultural competencies and utilizes this information for the enhancement of programming, and ability to communicate and foster relationships with a diverse group of individuals.
- Ability to travel in and around assigned communities to communicate with partners.
- Demonstrates ability to manage multiple daily, weekly, monthly, and long-term tasks by carefully setting priorities, meeting deadlines, and scheduling time efficiently.
- Ability to operate a computer and use a variety of common software programs including Microsoft Office.
- Effective written and verbal communication skills.
- Possesses strong interpersonal skills as demonstrated by compassionate, courteous, cordial, cooperative, and professional interaction with diverse groups of co-workers, external partners and community members
- Adheres to all The Food Trust and departmental policies and procedures.
- Attends all The Food Trust in-services as required.
- Flexibility to work varying hours (including early mornings, evening hours, and occasional weekend events), not to exceed a 20 hour work week

PHYSICAL DEMANDS
